

My personal recollection of results submitted for the 22nd Ward (6th Precinct) were the following:

Clearly, the results I am to believe were achieved in all *other* 23rd Legislative District polling places are almost impossible for one to realistically consider given the results I saw at 2510 S Kildare on February 2nd; where Lozano won handily with over 90% of the vote.

As such, please find my attached Freedom of Information Act Request, along with my strong encouragement to investigate, for voter fraud, the 23rd Legislative District results.
